Method Statement for external instructed groups at the Pinnacle Climbing Centre

Anyone bringing groups to the Pinnacle Climbing Centre must make sure that they have read, understood and are familiar with the conditions of use for the centre. The rules and conditions of use of the centre are to be followed at all times. The only exception to this would be if any of the rules listed below were to contradict the conditions of use in which case this document would take priority.

- The person/persons taking overall responsibility for the group must hold CWA/SPA minimum, and must present their MLTE log book with the relevant certificates and a copy of their first aid certificate and insurance certificates, on or prior to, their first session at the Pinnacle Centre.
- The person/persons instructing the group must have read and be familiar with the rules and conditions of use for climbing at the Pinnacle Centre. These rules must be adhered to at all times. This person is also responsible for making sure that the members of the group are familiar with the rules of the centre. If necessary, as well as a safety briefing, they will give a tour of the facilities.
- All members of the group must be supervised at all times. It is not acceptable for a supervised group with one instructor to be split between the bouldering room and the main room. The only exception to this is where members of the group are registered users at the Pinnacle Centre and have a registration card.
- If wishing to teach lead climbing in the centre then the instructor must hold a relevant qualification, (CWLA or MIA minimum).
- The instructors are to accept full responsibility for ensuring that members of their group are familiar with and adhere to the Pinnacle Climbing Centre rules.
- All climbers must wear rock-boots. The only exception to this is when their footwear has been approved by a Pinnacle Climbing Centre Manager.
- All members of the group involved in the climbing activities must wear helmets.
- The ground anchors are not to be used as direct belays.
- If supplying their own equipment, the instructors will accept full responsibility for its condition and suitability.
- The organisation booking the group in will accept full responsibility for paying for any damage caused to the Pinnacle Climbing Centre by members of their group during their visit.
